- ❖ All **dU** DMC partners must have the full proposal sent to the client within 72 hours; unless they advise the client of a delay.
- ❖ **dU** DMC partners can be contacted at any time during an event, by means of a mobile phone.

- ❖ The majority of **dU** DMCs have been with us for 15 years and have a proven track record in working with the overseas market.
- ❖ 98% of **dU** DMCs have been established for 10 years or longer.
